- 1. CUSTOMS CONTROLLED AREAS (CCA)**
- 2. CUSTOMS BROKER OR AGENT**

We wish to kindly advise ALL our Customs License Holders as listed above, that all your 2020 licenses have expired on 31<sup>st</sup> December 2020 and you should have renewed license before expiry date. In the event that you still have not renewed license, please kindly come in now to renew respective license before the 31<sup>st</sup> January 2021. Failure to renew by 31<sup>st</sup> January 2021, the Comptroller of Customs will proceed to cancel your respective license.

For the CCA licenses, the expiry date of 31<sup>st</sup> December is stipulated in Customs Regulations 2015 and pursuant to Parts 3, Section 15 of Customs Act 2014, failure to renew by 31<sup>st</sup> January 2021 will follow by the cancellation of your license.

For the Customs Broker licenses, the expiry date of 31<sup>st</sup> December is stipulated in Customs Regulations 2015 and pursuant to Part 18, Section 319 of Customs Act 2014, failure to renew by 31<sup>st</sup> January 2021 will follow by the cancellation of your license.
