This is a kind reminder that the rescheduled commencement date of 31<sup>st</sup> July 2022 is drawing near and we hope every business is now ready to commence issuing fiscal invoices and receipts as per requirements of the Tax Administration (Tax Invoice Invoice Monitoring System) Regulations 2020.
2. Please note that the Ministry will not accept any more requests for further time extensions as substantial time was provided since TIMS was launched in March 2020.
3. The Ministry will immediately commence with its enforcement actions for non-compliant taxpayers identified in breach of any regulatory requirements.
4. We greatly appreciate and applaud the commitment of those who have already installed an Electronic Fiscal Device and are issuing fiscal invoices. Please continue with your noted compliance record and the Ministry will continue to provide the priority support and assistance that is available at any time.




**MO LE AU TOTOGI LAFOGA UA RESITALAINA MO LE VAEGA MUAMUA (1) TIMS:**
