TEMPORARY CLOSING HOURS TO SELL ALCOHOL DURING THE EASTER HOLIDAYS:

To all Alcohol Licence Holders, please be informed that Alcohol Control Board has approved the following times and dates as temporary closing hours to sell Alcohol during the Easter holidays;

EASTER PUBLIC HOLIDAYS	CLOSING HOURS
Friday 7 th April & Saturday 8 th 2023.	Closing from 10pm on Thursday 6 th of April 2023 and re-open on Saturday 8 th April 2023 from 6am to 10pm.
Monday, 10 th April 2023.	Back to normal hours.

The above closing hours do not apply to Hotels for their Food & Beverage license only. This exemption is subject to the following conditions;

1. Alcohol is to be served with food within the vicinity of the licensed premises.
2. Alcohol is only served to the in-house guests of the hotel.
3. Sales of alcohol to the public from these licensed premises are strictly prohibited within the above-stated hours.
